Weddings & Events - Safety Plan -

- As mandated by the Provincial Public Health Order and the new Regional Measures Order for the Fraser Health Authority, in order to attend any function, held either indoors, under our events tent, or outdoors:
 - » *effective September 29th, all guests ages 12 years and older are required to show proof of being fully vaccinated with two doses of a COVID-19 vaccine*
 - » *Sandpiper Resort is required to collect the first and last names and telephone number, or email address, of every participant at an event*
 - *This information will be retained for thirty days, in case there is a need for contact tracing on the part of the medical health officer, in which case the information must be provided to the medical health officer within 24 hours of request; and*
 - *After a period of thirty days, this information will be destroyed*
- All resort-hosted dining events, weddings, elopements, and specialty events are currently subject to limited guest (patron) numbers:
 - » *Any guest count of over 10 people, for all indoor gatherings, must provide proof of double vaccination for all guests prior to their event date.*
 - » *Indoor weddings and funerals at Sandpiper Resort are currently allowed for up to 40 people (50% capacity) including the officiant, but not including staff.*
 - » *For use of our events tent, we are currently limited to 80 people including the officiant, but not including staff.*
 - » *This policy is subject to change. If the requirements for Step 3 of BC's Restart Plan are met, larger weddings may be allowed to be held indoors.*
- Events can only be hosted from noon until midnight, and no event will take place before or after one scheduled event at the same location, in one day.
- An event room will be cleaned and sanitized prior to the next event in the same premises.
- If live music is provided (performer(s) or DJ), a physical barrier must be installed between the performer(s) and the patrons.
- All staff will be wearing masks in designated areas.
- Patrons who leave the premises during the event must not be replaced by other patrons.
- Additional patrons may be present in other areas of our resort.
- Dining is available in individual servings, family style, or take-out.
- Masks must be worn by all diners upon entrance to the dining area, and may only be removed while eating and drinking.

- All surfaces are sanitized frequently throughout the day including high traffic areas, public restrooms, and door handles.
- Automated hand-sanitizer stations are available in highly-visible areas throughout the resort.
- All guests and staff must wash their hands frequently and for a minimum of 45 seconds before touching self-service food, utensils, and other items.

While we have always maintained high sanitation procedures, based on provincial and federal government recommendations and orders, we are strictly adhering to further guidelines:
